### **Conditions for request of bursary:**

#### Preamble:

IFOR would like every IFOR member to be represented at Council. Normal practice is that each branch, group or affiliate (BGA) pays the full costs of its Council representative(s).

IFOR's aim is to try to ensure that lack of money does not hinder any BGA from sending its representative(s) to Council. There is a limited bursary fund available to help with travel and accommodation costs. If your organisation feels unable to raise the full costs for your representative(s) you can apply for a bursary for part or all of the costs.

1. IFOR will give priority to those BGAs in greatest financial need who are unable to raise the full costs of representation at Council. If you do apply for a bursary, please consider how much you will really need and only apply for a partial bursary if this is really necessary.
2. The maximum bursary available will cover the costs of :
  - a. Board and lodging at the conference centre (€600 (for eight days) + €50 registration fee).
  - b. The cheapest air travel costs from your country to The Netherlands (travel within your own country and any refreshments are not included).
  - c. Public transport between the arrival airport and the conference centre (taxis will not be reimbursed) and
  - d. The cost of an entry visa if required (not including any travelling or any other costs involved in obtaining a visa).
3. IFOR is not responsible for any insurance costs (health, travel, etc.). Please, provide your own insurances.
4. Travel expenses will be reimbursed by inter bank transfer to the representative after the Council. Tickets and original receipts must be shown to the Financial Administrator at Council. Hand written receipts must include official stamps or

else they will not be recognized as valid receipts. If you require alternative arrangements for the reimbursements, please contact the Secretariat.

5. For administrative reasons, the International Secretariat in Alkmaar is advising branches to use the secretariat for purchasing and prepaying all air- and train tickets and the accommodation costs in Baarlo, the Netherlands..
6. First priority will go to those applications for bursaries for voting representatives from IFOR Branches received before 1<sup>st</sup> July.
7. Second priority will go to representatives from IFOR Groups and Affiliates received by 1<sup>st</sup> July.
8. Third priority goes to non-voting representatives from IFOR Branches received by 1<sup>st</sup> July.
9. Final priority goes to those requests received after 1<sup>st</sup> July.
10. The number of bursaries that can be offered will depend entirely on the funds available. IFOR cannot guarantee that all persons who request a bursary will be reimbursed. If you do not fulfil the criteria for a bursary or if IFOR, due to a lack of funding, cannot provide a bursary, you will be notified as soon as possible.
10. All requests for bursaries must be accompanied by a copy of the applicant's Branch/Group/Affiliate's most recent Annual Report and Accounts.
11. Should you have any problems, please do not hesitate to contact the Secretariat. Please, respect the stated deadlines.
